Safety: All floats, vehicles, and delegations are subject to COFECA safety requirements and to any inspections required by the appropriate authorities. COFECA may prevent any entry from participating if it presents a safety risk to participants, spectators, staff, volunteers, or property.

Responsibility: Each participating organization is responsible for the safe construction, operation, transportation, and handling of its float, vehicle, equipment, and materials. To the extent permitted by applicable law, COFECA shall not be responsible for damages, fire, accidents, losses, or injuries resulting from the actions, negligence, equipment, or materials of participants.

Compliance: The float and its content must substantially correspond with the description submitted. COFECA may cancel or deny participation for safety violations, false or incomplete information, unauthorized sponsors, undeclared advertising, or failure to comply with parade rules. In such cases, payments will not be refunded.

Clean-Up: Each participant is responsible for maintaining a clean area before, during, and after the event. If COFECA must provide additional clean-up because trash or materials are left behind, additional charges may apply.
